### Corporate (Transferable to another employee at the company)

- \$3,000.00 + GST one-time entrance fee
- \$113.00 + GST monthly dues (includes a \$10.00 Facility Enhancement Fee)
- \$600.00 minimum House account \*

### Senior Associate (Age 65+)

- \$1,500.00 + GST one-time entrance fee
- \$25.00 + GST monthly dues  
No minimum House account

### Young Professional (Age 35 or younger)

- \$750.00 + GST one-time entrance fee. This class of membership is capped at 350.
- \$38.00 + GST monthly dues (includes a \$10.00 Facility Enhancement Fee)
- \$300.00 minimum House account \*

### Family Membership (Adult Child or Parent of an existing Corporate, Resident or Senior Associate Member\*\*)

- \$500.00 + GST one-time entrance fee. This class of membership is capped at 350.
- Monthly dues based on age or residency as outlined in the other classes of membership
- Minimum House account based on your age or residency as outlined in other classes of membership\*

### Non – Resident (Must reside 120+ KM outside Calgary City limits)

- \$1,000.00 + GST one-time entrance fee
- \$25.00+ GST monthly dues
- No minimum House account\*

\* The fiscal year for our Minimum House account-spend is from April 1 – March 31. New Members are pro-rated based on the month you join.

\*\* Senior Associate Member Proposing a Family Member to join, must have originally joined as a Corporate or Resident Member.

### Billing and Payment Options

Upon acceptance into Membership, payment for the entrance fee for **Corporate** and **Personal** Memberships can be made in one of the following installments,

- One-time payment
- 3 installments of \$1,000.00 three consecutive months
- 6 installments of \$500.00 six consecutive months

The entrance fee payment will be posted to your first statement (*unless another payment option was selected*). Monthly dues are charged at the beginning of each month. Accepted forms of payment: Cash, cheques, credit cards (*with exception of Amex*) debit, online, or Pre-Authorized Debit (a form for this will be included with your New Members package).

As the Calgary Petroleum Club has recently celebrated our 70th year, our Board of Governors is offering an opportunity for multi-individuals from your business to join as new Corporate Members, at a reduced rate.

**When a minimum of 5 people** apply at the same time, our one-time entrance fee will be reduced by 10% (A \$300.00 savings on each membership)

(This includes a \$10.00 Facility Enhancement Fee for the 2017 renovations).

Minimum House account \$600.00 per year, per member. Our fiscal year goes from April to March.  
New members are pro-rated to this when set up with an account.
